EXECUTIVE ORDER NO. 120

**AN ORDER ISSUING ADDITIONAL GUIDELINES IMPOSED BY MUNICIPAL
TOURISM COUNCIL IN THE REOPENING OF TONDOL WHITE SAND BEACH
(TWSB) AND OTHER TOURIST ATTRACTION UNDER THE
MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) IN THE
MUNICIPALITY OF ANDA, PANGASINAN**

WHEREAS, in view of recent amendments to the Omnibus Guidelines on the Management of Community Quarantine in the Philippines and the issuances of component government agencies, there is a need to supplement the guidelines for the implementation of MGCQ in the Municipality of Anda under Executive Order No. 114 Series of 2020;

WHEREAS, there must be a continuous effort to address and contain the spread of COVID-19 for the welfare of the residents of Anda, so that responses and measures done will not be put to naught;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby order issuing additional guidelines imposed by Municipal Tourism Council in the reopening Of Tondol White Sand Beach (TWSB) and other tourist attraction under the Modified General Community Quarantine (MGCQ) in the Municipality of Anda, Pangasinan.

SECTION 1. TOURIST HOTEL ACCOMMODATION TO OPERATE:

1. Accommodation establishment which have secured a Certificate of Authority to Operate (CAO) or Provisional Certificate of Authority to Operate (PCAO) from the DOT shall allowed to operate.
2. Environmental Compliance Certificate.
3. Renewed Business Permit.

SECTION 2. TOURIST/VISITORS WITHIN PANGASINAN:

1. Allowed to stay overnight and more than 24 hours provided that they have approved registration, booking and Health Certificate.

SECTION 3. TOURIST/VISITORS OUTSIDE PANGASINAN:

1. Allowed to stay provided they comply with all health protocols and complete all documents required.

SECTION 4. TRAVELERS WITHIN PANGASINAN:

1. Allowed to enter Anda without Health Certificate, provided that period of stay shall not exceed 24 hours or no overnight stay.

SECTION 5. ONLINE REGISTRATION:

1. Hotel Management to submit the list of non-residents tourist to Tourism Office/PNP.

2. Cut-off time for submission:
- a. 5:00 PM to Tourism Office
 - b. Beyond 5:00 PM to PNP

SECTION 6. SEPARABILITY CLAUSE. Should any provision of the Order be declared invalid or unconstitutional, the other provisions unaffected thereby shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All orders, proclamations, rules, regulations, or parts thereof, which are inconsistent with any provision of this Order are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY. This Order shall take effect immediately and shall remain effective until revoked or amended.
