EXECUTIVE ORDER NO. 06

“DESIGNATION OF A PERSON WITH DISABILITY AFFAIRS OFFICER OR FOCAL PERSON AND ESTABLISHMENT OF PERSON WITH DISABILITY AFFAIRS OFFICE (PDAO) IN THE MUNICIPALITY OF ANDA, PANGASINAN”

WHEREAS, pursuant to Republic Act No. 10070, an Institutional Mechanism to ensure the Implementation of Programs and Services for Persons with Disabilities in every Province, City and Municipality, amending Section 40 of Republic Act No. 7277, otherwise known as the “Magna Carta of Disabled Persons” as amended, and for other purposes, a Person with Disability Affairs Office (PDAO) shall be organized and established in every province, city and municipality;

NOW THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby designate **WINELYN C. DELA CRUZ** as PWD Affairs Officer or Focal Person and the Municipal Social Welfare and Development Office as Person with Disability Affairs Office in the municipality.

Section 1. Functions.


The PWD Affairs Officer or Focal Person is expected to discharge the following:

1. Formulate and Implement policies, plans, and programs for the promotion of the welfare of PWDs in coordination with concerned national and local government agencies;
2. Coordinate the implementation of the provisions of RA 10070, Batas Pambansa Bilang 344, otherwise known as the Accessibility Law, and other relevant laws;
3. Represent PWDs in meetings of local development councils and other special bodies;
4. Recommend and enjoin the participation of Non-Government Organizations (NGOs) and People’s Organization (POs) in the implementation of all disability-related law and policies;
5. Gather and compile relevant data on PWDs in the localities;
6. Disseminate information including but not limited programs and activities for PWDs, statistics on PWDs including children with disability, trainings and employment opportunities for PWDs;
7. Submit reports to the Office of the Local Chief Executive on the implementation of programs and services for the promotion of the welfare of PWDs in their respective areas of jurisdiction;
8. Ensure the policies, plans and programs for the promotion of the welfare of PWDs are funded by both national and local government;
9. Monitor fund raising activities being conducted for the benefits of the PWDs;
10. Seek donations in cash and/or in kind from local or foreign donors to implement approved work plan for PWDS in accordance with existing laws and regulations; and
11. Perform such other functions as may be necessary for the promotion of the welfare of PWDs.

Section 2. Effectivity.

This Executive Order shall take effect upon the date of issue.
