**“AN ACT RECONSTITUTING/REORGANIZING THE MUNICIPAL DISASTER RISK
REDUCTION AND MANAGEMENT COUNCIL OF THE
MUNICIPALITY OF ANDA, PANGASINAN”**

WHEREAS, Section 5 of Article II of the 1987 Constitution provides that: “The maintenance of peace and order, the protection of life, liberty and property, and the promotion of general welfare are essential for the enjoyment by the people the blessing of democracy”;

WHEREAS, Section 16 of RA No. 7160 otherwise known as the Local Government Code of 1991 provides for the General Welfare clause, to wit:”Within their respective jurisdiction, local government unit shall... Promote health and safety,maintain peace and order, and preserve the comfort and convenience of the inhabitants”;

WHEREAS, Republic Act No. 10121, otherwise known as the “Philippine Disaster Risk Reduction and Management Act of 2010” provides for the organization of Local Disaster Risk Reduction and Management Councils;

NOW, THEREFORE I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, or hereby order;

SECTION 1. RECONSTITUTION/REORGANIZATION

The Local Disaster Risk Reduction and Management Council (LDRRMC) of the Municipality of Anda, Pangasinan is hereby reconstituted/reorganized and shall be known as the “MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC).”

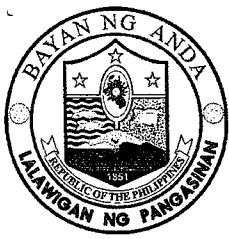
SECTION 2. COMPOSITION

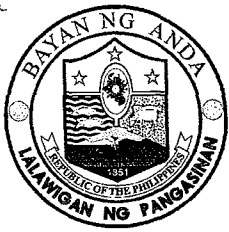

SECTION 3. FUNCTIONS

The Municipal Disaster Risk Reduction and Management Council (MDRRMC) shall have the following functions:

1. Approve, monitor and evaluate the implementation of the MDRRM Plan and regularly review and test the plan consistent with the other national and local planning programs;
2. Ensure the integration of disaster risk reduction and climate change adaption in Local Development and poverty reduction;
3. Recommend the implementation of forced or preemptive evacuation of local resident, if necessary; and
4. Convene the Local Council once every three (3) months or as necessary.

Section 4. EFFECTIVITY

This Executive Order shall take effect upon date of issue.
