**“REORGANIZING THE PROJECT MONITORING COMMITTEE IN THE  
MUNICIPALITY OF ANDA”**

**WHEREAS**, Executive Order No. 376 s. 1989, as amended by E.O 893 s. 1993, established the Regional Project Monitoring and Evaluation System (RPMES) to facilitate project implementation and devolve facilitation, problem-solving, monitoring and evaluation to foreign, national and locally-funded projects to the sub-national levels;

**WHEREAS**, the DILG MC 2004 – 78 dated June 22, 2004, directs the activation/reorganization of the Local Project Monitoring Committee to facilitate project implementation and devolve facilitation, problem – solving, monitoring and evaluation of foreign, national and locally – funded projects to the sub-national levels;

**NOW THEREFORE, I, JOGANIE C. RARANG**, Municipal Mayor of the Municipality of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize/reconstitute and mobilize the Project Monitoring Committee in the Municipality of Anda:

**SECTION 2. Functions.** – The Local Project Monitoring Committee shall:

1. Monitor and evaluate national-funded projects including development projects funded from the Internal Revenue Allotment (IRA) share of the LGUs or supported by funds released directly to the municipality, and
2. Project funded from the locally generated resources which are implemented within the respective areas.
