**CREATION OF LOCAL CULTURE AND THE ARTS COUNCIL
IN THE MUNICIPALITY OF ANDA, PANGASINAN**

WHEREAS, Sections 447 (a)(5)(xvi), 458 (a)(5)(xvi), and (a)(4)(viii) of Republic Act (RA) No. 7160, otherwise known as the "Local Government Code of 1991" or LGC, provided as part of the powers, duties, and functions of the Sangguniang Bayan, Sangguniang Panglungsod and Sangguniang Panlalawigan respectively, the approval of the ordinances that shall ensure the establishment of a local council whose purpose is the promotion of culture and the arts, coordinate with government agencies and non-governmental organization and appropriate funds for the support and development of said council, subject to availability thereof;

WHEREAS, Consistent with the above-stated purpose is the protection, preservation, and promotion of cultural heritage and the ethnicity of local communities. In line with this, the DILG-OSEC special provisions under Republic Act No. 10924 or the General Appropriations Act of 2017 mandated DILG to ensure the establishment of the local council. To strengthen the LGU as a cultural institution, its obligations prescribed in the National Cultural Heritage Act of 1009 are hereby rationalized as one of the functions of the Local Culture and Arts Council.

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, in the Province of Pangasinan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. Creation and Composition. The Local Culture and the Arts Council, is hereby created, to be composed of the following:

SECTION 2. Separability Clause. Should any provisions of this Order be declared invalid or unconstitutional, the other provisions unaffected thereby shall remain valid and subsisting.

SECTION 3. Repealing Clause. All orders, proclamations, rules, regulations, or parts thereof, which are inconsistent with any provisions of this Order are hereby repealed or modified accordingly.

SECTION 4. Effectivity. This Order shall take effect immediately in the exigency of public health and service.
