**EXECUTIVE ORDER NO. 29**  
**Series of 2020**

**“REORGANIZING/RECONSTITUTING THE MUNICIPAL PEACE AND ORDER  
COUNCIL OF THE MUNICIPALITY OF ANDA, PANGASINAN”**

**WHEREAS**, Section 16 of the Local Government Code provides for the General Welfare Clause, to wit:

*“Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall... maintain peace and order...”*

**WHEREAS**, the President of the Republic of the Philippines issued Executive Order No. 739 mandating the reorganization of the Peace and order Council in the National, Regional, Provincial, City and Municipal levels;

**WHEREAS**, Executive Order No. 773 dated January 5, 2009 further reorganized the Peace and Order Council, expanding its membership;

**WHEREAS**, the maintenance of the public order and safety in our community requires the concerted effort of our local government and other government institutions as well as the participation of the citizenry;

**NOW, THEREFORE, I, JOGANIE C. RARANG**, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby reorganized the Municipal Peace and Order Council and MPOC Technical Working Group of this municipality, as follows:

**SECTION 1. The Composition of the Municipal Peace and Order Council shall be Organized and Composed of the following:**

**SECTION 3. Duties and Functions**

The Chairman of the Municipal Peace and Order Council (MPOC) shall be responsible for the proper management and supervision of the civilian volunteer organization in coordination with the other appropriate government entities.

The MPOC shall have the following duties and functions:

- a. Formulate plans and recommend such measures which will improve or enhance peace and order and public safety in the Municipality;
- b. Monitor the implementation of peace and order programs and projects at the municipal level and the operation of the Civil Volunteer Self-Defense Organizations and such counter-insurgency programs and activities;
- c. Make periodic assessment of the prevailing peace and order situation in the municipality and submit a report thereon with recommendations to the chairman of the National Peace and Order Council; and
- d. Receive complaints against government personnel, civilian or military and endorse the same to the agency concerned ad demand/compel such agency to submit reports of action taken thereon.

**SECTION 4. Secretariat and Special Action Team.**

The Secretariat of the Municipal Peace and Order Council shall handle the administrative, operational and technical activities of the MPOC. These activities are:

- a. Prepare plans and programs for the consideration of the MPOC;
- b. Supervise, and direct and monitor, for the council, the implementation of approved policies, plans and programs;
- c. Undertake liaising and coordinate of activities with appropriate agencies of the government; and
- d. Provide a forum for the inter-disciplinary dialogue and deliberation of major issues and problems affecting peace and order.

The Secretariat shall be headed by the Municipal Local Government Operation Officer and shall be assisted in its functions and duties by the regular staff of the Mayor's Office.

**SECTION 5. Effectivity.**

The Executive Order shall take effect immediately.
