AN ORDER ORGANIZING QUICK RESPONSE TEAMS (QRTS) TO CARRY OUT THE TEST-TRACE-TREAT STRATEGY AGAINST COVID-19 IN THE LOCKDOWN AREAS OF THE MUNICIPALITY OF ANDA, PANGASINAN

WHEREAS, Section 2 of Executive Order No. 112 issued by the Office of the President authorizes Provincial Governors to impose, lift or extend Community Quarantine in component cities and municipalities, while Mayors may exercise the same authority in barangays;

WHEREAS, with the General Community Quarantine (GCQ) in effect in Metro Manila and Modified General Community Quarantine (MGCQ) in greater parts of the country, the Department of Interior and Local Government (DILG) said that Local Government Units (LGU) which impose localized lockdown in specific areas in their communities must have organized their Quick Response Teams (QRTs) that shall carry out the test-trace-treat strategy against COVID-19 in the lock areas;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan by virtue of the powers vested in me by law, do hereby organize a Quick Response Teams (QRTs) composed of the following:

Section 8. Responsibilities

1. To implement the strategy to contain the disease in the lockdown areas as well as implement social amelioration to alleviate the conditions of those affected;
2. Enforce stringent health protocols, aggressively conduct tracing, testing and isolation to contain and prevent the spread of COVID-19 in the lockdown areas.

Section 9. Separability Clause. Should any provision of the Order be declared invalid or unconstitutional, the other provisions unaffected thereby shall remain valid and subsisting.

Section 10. Repealing Clause. All orders, proclamations, rules, regulations, or parts thereof, which are inconsistent with any provision of the Order are hereby repealed or modified accordingly.

Section 11. Effectivity. This Order shall take effect immediately in the exigency of public health and service.
