**AN ORDER CREATING THE SPECIAL COMMITTEE ON ANTI-CRIMINALITY
INSURGENCY AND CRISIS MANAGEMENT
IN THE MUNICIPALITY OF ANDA, PANGASINAN**

WHEREAS, Section 16 of the Local Government Code provides for the general welfare clause, to wit:

“Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate or incidental for its efficient governance, and those which are essential to the promotion of the general welfare within their respective territorial jurisdiction, local government units shall ... maintain peace and order”.

WHEREAS, the maintenance of the public order and safety in our community requires the concerted effort of our local government and other government institutions as well as the participation of the citizenry.

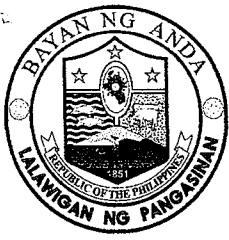

Section 3. Duties and Responsibilities.

The Committee shall have the following duties and responsibilities:

- a. Formulate plans and recommend to the MPOC such measures which will improve or enhance peace and order and public safety in the municipality;
- b. Make periodic assessment of the prevailing peace and order situation in the municipality and submit a report there on recommendations to the MPOC;
- c. Receive complaints against government personnel, civilian or military and endorse the same to the MPOC for appropriate action.

Section 4. Effectivity.

This Executive Order shall take effect immediately.
