**EXECUTIVE ORDER NO. 75**  
**Series of 2020**

**AN ORDER TO PROVIDE THE MANAGEMENT GUIDELINES FOR PROPER DISPOSAL OF SOLID WASTE AT TONDOL WHITE SAND BEACH (TWSB), PANACALAN BEACH AND OTHER BEACHES IN THE MUNICIPALITY OF ANDA, PANGASINAN**

**WHEREAS**, pursuant to Art. 1, Section 444 of the Local Government Code Annotated, the Municipal Mayor, as the Local Chief Executive of the Municipal Government shall exercise such powers and perform such duties and functions for efficient, effective and economical governance, the purpose of which is the general welfare of the municipality and its inhabitants;

**WHEREAS**, RA 9003 is a primary legislation on solid waste management providing a comprehensive, systematic and ecologically viable program that would:

- Ensure public health and protect the environment;
- Employ environmentally-sound methods to encourage resource construction and recovery and promote national research and development program;
- Encourage greater private sector participation while retaining the primary enforcement and responsibility of solid waste management with local government units;
- Integrate the ecological solid waste management and research conservation and recovery topics into the academic circular for formal and non-formal education.

**WHEREAS**, these plastics, styrofoam and other residual waste, when indiscriminately thrown alongside streets, riverbanks and along the shore are main contributor that clogged canals and impede the flow and navigation lane when reaches the shore;

**WHEREAS**, to conserve the natural beauty of the beach with harmonious relationship to its environment and ecological balance of nature, it is relevant to provide the management guidelines for the proper disposal of solid waste at Tondol White Sand Beach (TWSB), Panacalan Beach and other beaches as follows:

- All local tourist from Anda and incoming tourist from other places must bring their trash bag where the waste were kept and bring with them when they go home;
- Hotel accommodation owners shall provide trash cans/trash box per room for stay-in tourist;
- Tourism Personnel shall constantly monitor the area and maintain the cleanliness in Tondol White Sand Beach.

**NOW, THEREFORE, I, JOGANIE C. RARANG**, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law as the Local Chief Executive, do hereby order to provide management guidelines for proper disposal of solid waste at Tondol White Sand Beach (TWSB), Panacalan Beach and other beaches in the Municipality of Anda, Pangasinan.

**EFFECTIVITY:** This Executive Order shall take effect immediately upon signing hereof, shall remain in full force and effect unless revoked in the writing by the undersigned.
