EXECUTIVE ORDER NO. 78

**AN ORDER IMPLEMENTING THE GUIDELINES SET BY ANTI-COVID TASK FORCE
OF ANDA IN THE MUNICIPALITY OF ANDA, PANGASINAN
FROM JULY 31, 2020 TO AUGUST 07, 2020**

WHEREAS, the Local Government Code of 1991, provides that the Local Chief Executive shall exercise such powers and perform such duties and functions as provided by this code for efficient, effective and economical governance for the general welfare of the people;

WHEREAS, as unexpected, one of our townmate is positive from COVID-19 virus as a result of SWAB test conducted recently, and now is under quarantine. For this premise, the Task Force opt to place the municipality again under the General Community Quarantine status;

WHEREAS, on the 30th day of July 2020, the Anda Anti-COVID-19 Task Force set an implementing guideline to be observed and strictly enforced during the General Community Quarantine period;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, in coordination of the premise set forth by Anti-COVID Task Force of Anda, Pangasinan, do hereby implement the following under the General Community Quarantine period.

SECTION 1. CURFEW HOURS.

Shall start from 6:00 PM to 5:00 AM the following morning

SECTION 2. NOT ALLOWED TO GO OUT.

- 21 years old below and 60 years old above
- Pregnant women
- Immunocompromised patient

SECTION 3. ALLOWED TO GO OUT.

- 21 years old below accompanied by parent
- With Quarantine Pass (per household)
- Emergency cases
- Authorized Person Outside Residence (APOR)
- Fishermen and Farmers
- Senior Citizen to secure Brgy. Clearance (that no other person to accompany him/her to go outside)

SECTION 4. LIQUOR BAN.

- No selling of liquor from July 31, 2020 to August 07, 2020

SECTION 5. MARKET SCHEDULE.

- Same schedule (market goers are not allowed, if not their schedule)
- Buyers are not allowed without Quarantine Pass
- Visitors are not allowed to buy in Public Market

SECTION 6. NOT ALLOWED.

- No vendors are allowed to enter Anda from other towns

SECTION 7. TALIPAPA.

- Establishment of Talipapa is allowed within the barangay provided that buyers have Quarantine Pass
- Talipapa is open, the same schedule with the Public Market

SECTION 8. TOURIST SPOTS

- All tourist spots are **CLOSED** to public.

SECTION 9. WORK FORCE.

- Only Skeletal Force shall be allowed to work, except frontliners from RHU/LDRRM

SECTION 10. ESTABLISHMENT.

- Mandatory wearing of facemask and face shield to all workers and employees of establishment

SECTION 11. SUNDAYS.

- All establishment are **CLOSED**

SECTION 12. FOR BHWs AND BARANGAY OFFICIALS.

- Report all violators on Quarantine Protocols and submit affidavit to Rural Health Office for endorsement to PNP for filing a case under Revised Penal Code Article 151

SECTION 13. BUS, JEEPNEY, UV EXPRESS AND PRIVATE CARS.

Check for the completeness of documents:

LSI (outside Province): Brgy. Certificate, Medical Certificate, Travel Authority

LSI (within the Province): Brgy. Certificate, Medical Certificate

UPOR (within the Province): Brgy. Certificate (indicating the purpose of travel)

APOR : Certificate of Employment or Company ID, Brgy. Certificate

FRONTLINERS: Frontliner ID

SECTION 14. EFFECTIVITY.

This Order shall take effect immediately.
