**EXECUTIVE ORDER NO. 85**  
**Series of 2020**

**AN ORDER CREATING OF A TRICYCLE TASK FORCE WHICH IS SEPARATE AND  
DISTINCT FROM ITS TRICYCLE REGULATORY BOARD OR UNIT IN THE  
MUNICIPALITY OF ANDA, PANGASINAN.**

**WHEREAS**, the Local Government Code has devolved to all city and municipal government, through their respective Sanggunians, the power to regulate the operations of tricycle/pedicabs and to grant franchises for the operation thereof within their territorial jurisdiction;

**WHEREAS**, this devolved responsibility, however, remains subject to the guidelines prescribed by the Department of Transportation and Communications (now DOTr);

**WHEREAS**, DOTCs "Guidelines to implement the devolution of LTFRB's Franchising over tricycles-for-hire to Local Government Units pursuant to the Local Government Code (RA 7160)"

"For safety reasons, no tricycle should operate on national highways utilized by 4- wheel vehicles greater than 4-tons and where normal speed exceeded 40 kph, however, the SB/SP may provide exemptions if there is no alternative route."

**NOW, THEREFORE, I, JOGANIE C. RARANG**, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby order the creation of a Tricycle Task Force to be composed of the following;

**SECTION 1. Compositon.**

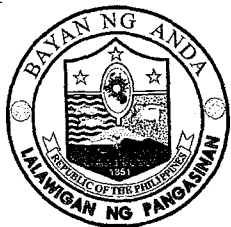
The Task force shall be composed of the following:

**SECTION 2. Duties and Functions.**

The Task Force shall have the following responsibilities:

- a. Conduct of meetings, public consultations and hearing with stakeholders, and survey/ocular inspection of the zone/area of tricycle operations with special focus on the following:
  1. Identification of national roads within the area of jurisdiction of the LGU.
  2. Schematic map showing portion(s) of the national highway to be allowed use by tricycles for lack of an alternative route.
  3. Color scheme or any visible emblem/sign imposed on tricycle which are allowed to ply a route which traverses a national highway; and

4. Proposed penalties to be imposed on violators.

**SECTION 3. REPEALING CLAUSE.**

All previous issuances, rules and regulations inconsistent with this directive shall be deemed repealed or modified accordingly.

**SECTION 4. SEPARABILITY CLAUSE.**

If for any reason any part or provision of this EO shall be held unconstitutional or invalid, other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 5. Effectivity:** The Executive Order shall take effect immediately.
