EXECUTIVE ORDER NO. 87
Series of 2020

PROHIBITING THE USE OF GOVERNMENT VEHICLES FOR PURPOSES OTHER THAN OFFICIAL BUSINESS, AND FOR OTHER PURPOSES IN THE MUNICIPALITY OF ANDA, PANGASINAN

WHEREAS, pursuant to Republic Act. No. 7638, it is declared policy of the State to ensure a continuous, adequate, reliable and economics supply of energy through the judicious conversation, renewal and efficient utilization of energy, to keep pace with the country's growth and economic development;

WHEREAS, the continuous rise in the pieces of oil in the world market calls for the government to exert to promote the judicious use of our energy resources through intensified conservation effort and efficient utilization thereof; and

WHEREAS, there is a need to strengthen the government's efforts against use of government vehicles for purposes other than official business in line with the government's energy saving and anti-graft and corruption campaigns.

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers verted in me by law, do hereby order:

SECTION 1. All government agencies and offices are prohibited from using government vehicles for purposes other than official business: provided, that in every case, the trip ticket authorizing the use of the vehicle shall be signed by Municipal Mayor: provided, further, that ambulances and vehicles used by intelligence and investigative agencies of the government shall not be covered by the foregoing proviso.

The use of Municipal Government vehicles on Saturdays, Sundays, legal holidays, or out of the regular office hours or outside the route of the officials or employees, shall unless properly authorized, be PRIMA FACE evidence of violation of the section in the administrative proceedings against the officials and employees responsible of such violation.

All vehicle keys of the Municipal Government must be kept under the custody of the Office of the Mayor.

SECTION 2. The use of municipal government vehicles for private social functions such as receptions, ball, theatres, and for other personal purposes is absolutely prohibited. Likewise, use thereof by the spouses, children, relatives, friends, and the like of the officials entitled thereto, even if they are in the company of said officials, is strictly prohibited.

SECTION 3. The republic is hereby encouraged to report any unofficial use of Municipal government vehicles through the following;

The report shall contain, among others, the type of vehicle, plate number, and the place and time where the vehicle is found preferably with pictures.

SECTION 4. Strict compliance by all officers or employees of the municipal government, with the provisions of this order is enjoined.

SECTION 5. This Executive Order shall take effect immediately.
