EXECUTIVE ORDER NO. 94
Series of 2020

AN ORDER RECONSTITUTING/REORGANIZING THE MUNICIPAL ASSESSMENT TEAM (MAT) FOR THE SEARCH OF THE CLEANEST GREENEST AND SAFEST BARANGAY IN THE MUNICIPALITY OF ANDA, PANGASINAN

WHEREAS, Section 34 of the Local Government Code (LGC) of 1991 states that “As the basic political unit, the Barangay serves as the primary planning and implementing unit of government policies, plans, programs, projects and activities in the community, and as a forum wherein the collective views of the people maybe expressed, crystallize and considered, and where disputes maybe amicably settled”. Meanwhile, pursuant to LGC of 1991, the Municipal Mayor exercise general supervision and control over component barangays including its officials to ensure that they act within the prescribed powers provided under Sec. 4, Art. X, 1987 Constitution and Section 25 and 32 of the LGC of 1991;

WHEREAS, it is the policy of the Local Government of Anda to ensure that the barangays play an active role and hold them accountable to their actions/inaction toward the monitoring and regulation of the national and local laws, policies and guidelines pertaining to environmental management, peace and order and public safety. It also serves as reminder for them to exercise their powers in ensuring that the law is strictly enforced, followed and implemented. Further, it intends to enjoin them to undertake the responsibility of improving the management of their community;

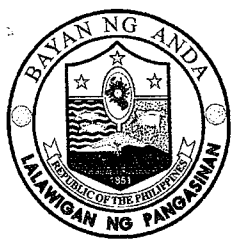
WHEREAS, the objective of the Search for the Cleanest, Greenest and Safest Barangay is to assess their performance in implementing environment management, preservation and protection programs and ensuring public order and safety in the community, specifically aims to:

- Determine the level of the performance of the component barangay;
- Identify priority areas to improve the cleanliness and beautification of the barangay as well the safety of the community for intervention;
- Recognize top performer barangays

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of the Municipality of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby order Organizing the Municipal Assessment Team (MAT) for the Search of the Cleanest Greenest and Safest Barangay in the Municipality of Anda, Pangasinan.

Section 2. There is hereby assigned Barangay Validation Team (BVT) clustered in three (3) with the following composition:

CLUSTER - B

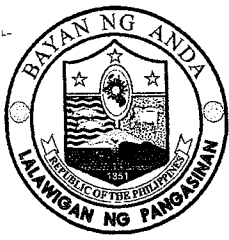

Section 3. Functions – The Municipal Assessment Team and the Barangay Validation Team (BVT) shall:

- 1) The BVT shall use a rating scale wherein the barangay has to comply with the requirement of the three assessment areas:
 - Cleanest – encourage all barangay in the Municipality of Anda, Pangasinan to maintain and sustain cleanliness in their areas;
 - Greenest – raise awareness to the society in the importance of planting and saving trees, express our concern to the environment and diminish the unfavorable effects of climate change;
 - Safest – sustain peace and order condition and ensure public safety.
- 2) The BVT shall ensure data availability or accessibility to the Municipal Assessment Team (MAT);
- 3) The BVT shall assess the barangay using the following indicators;
- 4) The MAT shall take lead in the documentation and interview with the Barangay Officials, functionaries and household;
- 5) The MAT shall recommend list with additional validation measures to be prevented to the SWMB, MPOC and MADAC for approval.

Section 7. Separability Clause.

Any provision of this Executive Order declared illegal shall not nullify the other provisions hereof provided that the remaining provisions can be given force and effect to accomplish the objectives of this Executive Order.

Section 8. Effectivity.

This Executive Order shall take effect immediately.
