**REORGANIZING/RECONSTITUTING THE MUNICIPAL COUNCIL FOR THE
PROTECTION OF CHILDREN OF THE MUNICIPALITY OF ANDA, PANGASINAN**

WHEREAS, Section 3, Paragraph 2 of Article XV of the 1987 Philippine Constitution provides for the protection of children, to wit;

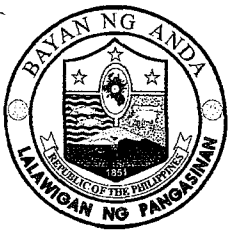
“(2) The right of children to assistance, including proper care and nutrition and special protection from all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development.”

WHEREAS, DILG Memorandum Circular No. 2002-121 dated August 2, 2002, provides for the organization and strengthening of the Local Councils for the Protection of Children (LCPC) which will serve as an advisory body of the Local Government Unit towards the promotion, development and protection of children;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize the Municipal Council for the protection of Children (MCPC) of Anda, Pangasinan as follows;

SECTION 1. COMPOSITION. The Municipal Council for the Protection of Children shall be composed of the following:

SECTION 2. FUNCTIONS: The Municipal Council for the Protection of Children shall have the following functions:

- A. Formulate plans, programs and policies for children that are gender-fair culturally relevant and responsive to the need of diverse groups of children from 0 to below 18 years of age;
- B. Prepare AWWP of children and recommend appropriation to the Sanggunian;
- C. Prepare coordinate linkages with other agencies and institutions in the planning, monitoring and evaluation of plan for children;
- D. Provide technical assistance and recommend financial support to the Barangay Council for the Protection of Children;
- E. Establish and maintain database on children in the Municipality;
- F. Foster education on every child;
- G. Advocate for the establishment and maintenance of playgrounds, day care centers and other facilities necessary for child and youth development;
- H. Recommend local legislations promoting child survival, protection, participation and development, especially on the quality of television show, print media and coverage, which is detrimental to children and with appropriate funding support;
- I. Assist children in need of special protection and refer cases filed against child abusers to proper agencies/institutions;
- J. Conduct capability building programs to enhance knowledge and skills in handling children's program;
- K. Document Barangay best practices on children;
- L. Monitor and evaluate the implementation of the program and submit quarterly status reports to the Provincial Children's Protection Council;
- M. Perform such other functions as provided for the ECCD and other child - related laws.

SECTION 3. SECRETARIAT.

The Municipal Social Welfare and Development office headed by the MSWDO, Mr. Jowey C. Celzo shall be designated as the Secretariat to the MCPC.

SECTION 4. FUNDING.

As per Section 15 of RA 9344 otherwise known as the "Juvenile Justice and Welfare Act of 2006" mandates LGUs to establish Local Councils for the Protection of Children (LCPC) and allocate 1% of the Internal Revenue Allotment for its strengthening and implementation of programs, projects and activities.

SECTION 5. EFFECTIVITY.

This Executive Order shall take effect immediately.
