EXECUTIVE ORDER NO. 103
Series of 2020

AN ORDER PRESCRIBING IMPLEMENTING GUIDELINES GOVERNING AN ACTIVITIES RELATING TO THE OBSERVANCE OF UNDAS SEASON IN ALL PUBLIC AND PRIVATE CEMETERIES EFFECTIVE OCTOBER 26, 2020 TO NOVEMBER 06, 2020 IN THE MUNICIPALITY OF ANDA, PANGASINAN

WHEREAS, on 28 September 2020, the IATF issued Resolution No. 75-A placing the Ilocos Norte, Ilocos Sur, La Union, Pangasinan and Dagupan City as under Modified General Community Quarantine (MGCQ) beginning October 01, 2020 until October 31, 2020 pursuant to the appeals of the Local Government Units and recommendations of the IATF Screening and Validation Committee without prejudice to the declaration of Localized Enhanced Community Quarantine in critical areas;

WHEREAS, Resolution No. 72, S2020 dated September 17, 2020 ratified the decision of the IATF Technical Working Group. Notwithstanding the provisions of the Omnibus Guidelines on the Implementation of the Community Quarantine in the Philippines, as amended, these rules shall govern all activities relating to the observance of UNDAS Season in all private and public cemeteries, memorial parks, including columbarium and the like, effective upon approval of this Order and until November 15, 2020;

NOW, THEREFORE, I, JOGANIE C. RARANG, by virtue of the powers vested in me by law as Municipal Mayor of Anda, Pangasinan, do hereby order prescribing implementing guidelines governing all activities relating to the observance of UNDAS Season in all private and public cemeteries as follows;

SECTION 1. In all public and private cemeteries;

1. Closed on October 26 to November 6, 2020.
2. 15 to 65 years old are allowed.
3. No vendors are allowed within the premise of the cemetery.
4. Liquors, deadly weapons, pets and speakers are not allowed.
5. Bring your own food and drinks.

SECTION 2. LSI and visitors;

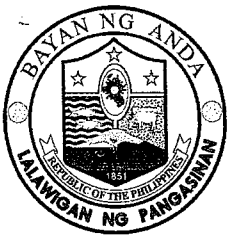
1. Visitors are only allowed 24 hours with the following required papers:
 - a) PNP special pass
 - b) Travel pass and ID
 - c) Local Residents Barangay Clearance
2. Incoming Visitors (outside/inside Pangasinan)
 - a) Undergo Rapid Test
3. Local Stranded Individual (LSI)
 - a) Medical Certificate – Public Hospital/Institution

SECTION 3. PNP Deployment

- 1) October 20 to 25 2020 – Deployment of PNP
- 2) Public Assistance Desk for every cemetery with the assistance of Brgy. Tanod

SECTION 4. Visiting hours before October 26, 2020

- 1) Start from 6:00 am to 6:00 pm

SECTION 5. SEPARABILITY CLAUSE. Should any provision of the Order be declared invalid or unconstitutional, the other provisions unaffected thereby shall remain valid and subsisting.

SECTION 6. REPEALING CLAUSE. All orders, proclamations, rules, regulations, or parts thereof, which are inconsistent with any provision of the Order are hereby repealed or modified accordingly.

SECTION 7. EFFECTIVITY. This Order shall take effect immediately and shall remain effective during the period of Modified General Community Quarantine (MGCQ) until revoked or amended.
