**DESIGNATION OF ANDA, PANGASINAN ANTI DRUG ABUSE COUNCIL -  
REPORTING SYSTEM (ADAC - RS)**

**WHEREAS**, President Rodrigo Roa Duterte acknowledged the proliferation of illegal drugs as a primary hindrance to the development of the community;

**WHEREAS**, the Department of Interior and Local Government (DILG) and the Dangerous Drugs Board (DDB) accelerated and cascaded the campaign against anti-illegal drugs through the Local Anti - Drug Abuse Councils (ADACs) that have a critical role in the coordination and proper monitoring of drug-related incidents;

**WHEREAS**, the role of the Local ADACS entail cohesion of policies for the inter-local government roles which can provide enabling environment for functional and effective ADACs;

**WHEREAS**, pursuant to DILG - DDB JMC No. 2018 - dated May 21, 2018 entitled Implementing Guidelines on the Functionality and Effectiveness of Local Anti-Drug Councils, LGUs shall designate two (2) focal persons, members of the CADAC/MADAC preferably holding plantilla positions, for Anti - Drug Abuse Council - Reporting System (ADAC - RS) and endorse two (2) encoders who shall assist the focal persons in recording information in the system through a Special Order;

**NOW, THEREFORE, I, JOGANIE C. RARANG**, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby designate focal persons for Anda Anti- Drug Abuse Council - Reporting System (ADAC-RS) as follows:

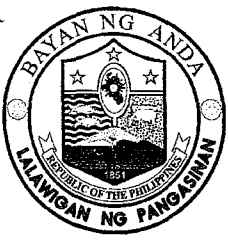
**SECTION 1. COMPOSITION.** The Anda Anti - Drug Abuse Council - Reporting System (ADAC-RS) shall have the following composition:

**SECTION 2. FUNCTIONS.** The Anda Anti - Dug Abuse Council -Reporting System (ADAC-RS) Focal Persons shall:

**Focal Persons:**

- Encode the necessary information of PWUD who surrendered in accordance with the Community - Bases Treatment and Rehabilitation Monitoring Form
- Ensure the monthly submission reports
- Ensure the accuracy and confidentiality of data

- d. Ensure that data of all PWUD who surrendered to authorities from July 2016 to December 2017 be encoded in the system following a specified schedule based on DILG – DBB JMC No. 2018 – 01
- e. In case there is no person who surrendered for the month, report the same to the DBB through e-mail
- f. Report problems encountered in the ADAC 00 RS by filing out the Issue Report Form

**SECTION 3. EFFECTIVITY.**

The Executive Order shall take effect immediately.
