EXECUTIVE ORDER NO. 119

**ESTABLISHING THE MUNICIPAL REHABILITATION REFERRAL DESK AND DESIGNATING
THE MUNICIPAL HEALTH OFFICER AS THE DUTY/DESK OFFICER**

WHEREAS, Section (A) of Dangerous Drugs Board Regulation No. 03, Series of 2017, provides for the establishment of Rehabilitation Referral Desk in every barangay to endorse drug dependents to the City/Municipal Anti-Drug Abuse Council or to the duly authorized representative of the Dangerous Drugs Board pursuant to Article VIII of RA 9165 otherwise known as the Comprehensive Dangerous Drugs Act of 2002;

WHEREAS, pertinent memoranda from DILG and DBB were issued to enjoin local government units and other concerned agencies to implement the program;

WHEREAS, to fully operationalize this program and ensure its functionality, there is also felt need to establish at the municipal level;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan by virtue of the power vested on me by the RA 7160 otherwise known as Local Government Code of 1991 and other existing laws do hereby direct the following:

SECTION 1. The Municipal Rehabilitation Referral Desk of Anda, Pangasinan is hereby established.

SECTION 2. The Municipal Health Officer is hereby designated as the Duty/Desk Officer of the Municipal Rehabilitation Referral Desk with the following functions:

1. Man the Municipal Rehabilitation Desk;
2. Provide assistance to the Desk/Duty Officers of the established Barangay Rehabilitation Referral Desks;
3. Serve as the coordinating arm in referring or endorsing drug dependents to the Municipal Anti-Drug Abuse Council for screening using Alcohol, Smoking and Substance Involvement Screening Test (ASSIST);
4. Help in referring expected drugs users to the MADAC and other institutions for corresponding counselling and/or rehabilitation;
5. Monitor progress of surrenderers; and
6. Perform other duties and functions as may be deemed necessary.

SECTION 3. Funding. An amount depending on the perceived need shall be set aside every year and to be included in the Annual Budget/Appropriations for the operation and functionality of the Rehabilitation Referral Desk as one of the components in the Municipal Anti-Drug Abuse Program in addition to the appropriations from the Offices of the Municipal Mayor and Municipal Health Office.

SECTION 4. Let copies of this Executive Order be furnished to Governor Amado I. Espino III, Municipal Anti-Drug Abuse Council, Sangguniang Bayan, DILG, PDEA, PNP and other law enforcement agencies for their information, reference and appropriate action.

SECTION 5. Effectivity. This Executive Order shall take effect immediately.
