**AN ORDER CREATING THE COMMITTEE ON MARKET OF  
THE MUNICIPALITY OF ANDA, PANGASINAN**

**WHEREAS**, Public Market is an important access to fresh, healthy food to providing important revenue streams, markets positively impost local business, government and residents. But, perhaps most important is the way markets serve as public gathering laces for people from the barangay;

**WHEREAS**, a public market is made up of small independent businesses, and each shop or stall is owned-operated. Rather than one company selling every item, like you would find in a supermarket, a public market features dozens of vendors selling food and other products they made themselves;

**WHEREAS**, the Municipal Government owns the Anda Public Market in Poblacion and there is a need to create the Market Committee to address certain needs and concerns at the said establishment;

**NOW, THEREFORE, I, JOGANIE C. RARANG**, Municipal Mayor of Anda, Pangasinan by virtue of the powers vested in me by law, do hereby create the Committee on Market of the Municipality of Anda, Pangasinan composed of the following:

**SECTION 1. COVERAGE.** This Executive Order shall cover the Old Public Market, New Wet Market and Pasalubong Center.

**SECTION 2. COMPOSITION.** The Committee on Market shall be composed of the following:

**SECTION 3. DUTIES AND FUNCTIONS.** The Committee shall perform the following functions:

1. Institute measures to be taken against erring lessees and vendors in the Old Public Market, Wet Market and Pasalubong Center;
2. Institute measures to address the proliferation of illegal vendors selling their goods in or about the premises of the Public Markets and other talipapa, and bagsakan nearby;
3. Study, deliberate and recommend appropriate action on projects for better revenue generation of the municipality which shall be conducted in the areas of coverage;
4. Adopt guidelines and procedure relative to the awarding of Public Market Stalls to qualified lessee-applicants;
5. Study and implement effective sectioning of dry goods, agricultural products, native goods and other products sold in the market; and
6. Perform other functions necessary to attain the objectives of this Executive Order.

**SECTION 4. DUTIES/FUNCTIONS OF THE SECRETARIAT/TECHNICAL WORKING GROUP.** The Secretariat/TWG shall perform the following functions:

1. Provide the needed technical and administrative support;
2. Document the proceedings of the Committee;
3. Prepare the minutes of the meetings, resolutions, recommendations, and all other official communications of the Committee;
4. Serve and follow up resolutions, recommendations, and communications of the Committee to concerned individuals, offices, agencies, or entities, and report the result to the Committee;
5. Keep the records of the Committee; and
6. Perform other functions which the Committee may require.

**SECTION 5. MEETINGS AND QUORUM.** The Committee shall meet as often as necessary. A majority of the members present shall constitute a quorum.

**SECTION 6. SEPARABILITY AND EFFECTIVITY.** This Executive Order shall take effect immediately and shall be valid unless sooner revoked or amended.
