**AN ORDER REORGANIZING/RESTRUCTURING FISHERIES AND AQUATIC
RESOURCE MANAGEMENT COUNCIL (FARMC) IN THE
MUNICIPALITY OF ANDA, PANGASINAN**

WHEREAS, pursuant to IRR of RA 8550 as amended by Republic Act 10654, Section 69 – there shall be established in the national level and in all municipalities/cities abutting municipal waters as defined by this code. The FARMCs shall be form by fisherfolk organizations/cooperatives and NGOs in the locality and be assisted by the LGUs and other government entities. Before organizing FARMCs, the LGUs, NGOs, fisherfolk and other concerned POs shall undergo consultation and orientation on the formation of FARMCs.

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize/restructure Fisheries and Aquatic Resource Management Council (FARMC) in the Municipality of Anda, Pangasinan composed of the following:

SECTION 1. Composition of the Municipal FARMC:

SECTION 2. FUNCTIONS OF THE MFARMCs – the MFARMCs shall exercise the following functions:

- a. Assist in the preparation of the Municipal Fishery Development Plan and submit such plan to the Municipal Development Council;
- b. Recommend the enactment of Municipal Fishery Ordinances to the Sangguniang Bayan through its Committee on Fisheries;
- c. Assist in the enforcement of fishery laws, rules and regulations in municipal waters;
- d. Advise the Sangguniang Bayan on fishery matters through its Committee on Fisheries, if such has been organized; and
- e. Perform such other functions which may be assigned by the Sangguniang Bayan.

SECTION 3. SECRETARIAT – the Secretariat shall be composed of the following:

SECTION 4. DUTIES AND RESPONSIBILITIES:

- a. Shall give all notices required and keep the minutes of all meetings of the FARMCs;
- b. Shall have custody of the correspondence, files and all other papers that are to kept; and
- c. Shall perform all such other duties and responsibilities as the council may assign to them.

SECTION 5. MEETINGS AND QUORUMS. The Committee shall meet as often as necessary. A majority of the members present shall constitute a quorum.

SECTION 6. SEPARABILITY AND EFFECTIVITY. This Executive Order shall take effect immediately and shall be valid unless sooner revoked or amended.
