**REORGANIZING/RECONSTITUTING THE MUNICIPAL FISHERIES AND AQUATIC
RESOURCES MANAGEMENT OF THE MUNICIPALITY OF ANDA, PANGASINAN**

WHEREAS, Section 69, Article II of Republic Act No. 8550, otherwise known as the Philippine Fisheries Code of 1998 provides for the creation of Fisheries and Aquatic Resources Management Councils (FARMCs) both on the national level and in all cities and municipalities bordering municipal waters;

WHEREAS, DILG Memorandum Circular No. 99-142 and 2001-131 support the creation of FARMCs as well as encourage local government units to incorporate in their local development plans and budget, programs and projects related to fisheries and aquatic resource management;

WHEREAS, the FARMC is by law a body that would empower the fisherfolk to be an active partner of the government in protecting our fisheries and aquatic resources and consequently eradicate poverty among marginal folks;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of the Municipality of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize/reconstitute the Municipal Fisheries and Aquatic Resources Management Council (MFARMC) of the Municipality of Anda as follows:

SECTION 1. COMPOSITION.

SECTION 2. FUNCTIONS.

The Municipal FARMC shall exercise the following functions:

- A. Assist the preparation of the Municipal Fishery Development Plan and submit such plan to the Municipal Development Councils;
- B. Recommend the enactment of municipal fishery ordinances to the Sangguniang Bayan its Committee on Fisheries;
- C. Assist in the enforcement of fishery laws, rules and regulations in municipal waters;
- D. Advice the Sangguniang Bayan on fishery matters through its Committee on Fisheries, if such has been organized; and
- E. Perform such other functions, which may be assigned by the Sangguniang Bayan.
