**“UPDATING AN EXECUTIVE ORDER IMPLEMENTING THE EVACUATION CENTER
PREEMPTIVE AND FORCE EVACUATION GUIDE AND SYSTEM EVALUATION OF
THE MUNICIPALITY OF ANDA, PANGASINAN”**

WHEREAS, Section 5 of Article II of the 1987 Constitution provides that: “The maintenance of peace and order, the protection of life, liberty and property, and the promotion of general welfare are essential for the enjoyment by the people the blessings of democracy”;

WHEREAS, Section 16 of RA No. 7160 otherwise known as the Local Government Code of 1991 provides for the General Welfare clause, to wit:” ...Within their respective jurisdiction, local government unit shall... promote health and safety, ...maintain peace and order, and preserve the comfort and convenience of the inhabitants”;

WHEREAS, Republic Act no. 10121, otherwise known as the “Philippine Disaster Risk Reduction and Management Act of 2010” provides for the organization of Local Disaster Risk Reduction and Management Councils, thereby replacing the existing Municipal Coordinating Councils;

WHEREAS, the Municipal Disaster Risk Reduction Action Plan (2013-2018), of Anda, Pangasinan, which was adopted by the Sangguniang Bayan Municipal Resolution No. 32 series of 2014 dated 17th day of June 2015 stated that Evacuation Center Management is under the Department of Education, Sangguniang Barangay and Civil Volunteer Officer (CVO);

WHEREAS, the different public schools of Anda, Pangasinan will provide School Coordinator to coordinate with the member of the MDRRMC in case a need of Evacuation Center in their area of responsibility;

WHEREAS, the Designated Evacuation Center of the Barangays are the Public Schools and / or Barangay Gym and /or Barangay Hall, where needed basic necessities of the evacuees could be provided as assisted by the School Coordinator;

WHEREAS, the Municipal Hall with all the basic necessities needed by the evacuees will serve as Evacuation Center as the need arises;

WHEREAS, as previous experience during the previous typhoon, the different churches in the Barangay Poblacion, Anda, Pangasinan served as an Evacuation Center;

WHEREAS, the Evacuation Guide be posted in all the Public Schools in the form of a tarpaulin or other printed materials that could withstand the calamities cited that the municipality are vulnerable;

WHEREAS, Executive Order No. 14, series of 2017, titled “AN ACT RECONSTITUTING/ REORGANIZING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL OF THE MUNICIPALITY OF ANDA, PANGASINAN, cited the Heads of Sectoral teams and Cited hereof:

SECTION 1. FUNCTIONS

The sectoral team should have a close coordination in time of calamities, disaster and the need arise.

SECTION 2. RECONSTITUTION/REORGANIZATION

Evacuation Center, Evaluation Guide System of Anda, Pangasinan is hereby reconstituted / reorganized and shall be known as the **“EVACUATION CENTER, EVACUATION GUIDE AND SYSTEM EVALUATION.”**

SECTION 3. EFFECTIVITY

This Executive Order shall take effect upon date of issue.

NOW THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan by virtue of powers vested in me by law, do hereby order.
