**REORGANIZING/RECONSTRUCTING THE MUNICIPAL NUTRITION COMMITTEE**

**WHEREAS**, there is a need to reorganize the Municipal Nutrition Committee pursuant to PD491 Nutrition Act of the nutrition in relation to sec. 17 of Local Government Code and DILG MC No. 2017-89;

**WHEREAS**, malnutrition continues to be a major problem, affecting preschoolers and school children;

**WHEREAS**, this continued prevalence of malnutrition is unacceptable since it compromises the growth and development not only at individuals, but also of our community and of the Municipality of Anda;

**WHEREAS**, malnutrition is caused by several factors that cut across various sectors;

**WHEREAS**, sectoral action to address malnutrition can have a better impact when coordinated, and integrated;

**WHEREAS**, such coordinated and integrated action can be made possible through a mechanism that will bring the sectors together for shared and responsibility on matters related to nutrition improvement;

**WHEREAS**, a need to create a Municipal Nutrition Committee (MNC), as a Sub-Committee of the Local Development Council;

**NOW THEREFORE, I, JOGANIE C. RARANG**, Municipal Mayor of Anda, Pangasinan by virtue of the powers vested in me by law, do hereby ORDER the following to wit;

**SECTION 1. REORGANIZED OF THE MUNICIPAL NUTRITION COMMITTEE.**

The MUNICIPAL NUTRITION COMMITTEE (for brevity) in the Municipal Government of Anda is hereby reorganized to be composed of the following:

**SECTION 2. DUTIES, FUNCTION, AND RESPONSIBILITIES OF MUNICIPAL NUTRITION COMMITTEE.**

The Municipal Nutrition Committee shall perform the following duties, functions, and responsibilities:

- a. Formulate and implement local food and nutrition policies, plans and interventions for nutrition improvement;
- b. Monitor and evaluate the efficiency and effectiveness of the plan for nutrition improvement;
- c. Identify and mobilize local resources for nutrition interventions;
- d. Advocate for local support for the nutrition plan to sustain nutrition improvement.

**SECTION 3. TERM OF OFFICE.**

The term of office of the members of the MNC shall be until noon of June 30, 2022. However, members of the MNC may act on hold-over capacity until their successor shall have been duly appointed and qualified.

**SECTION 4. FILLING UP OF VACANCY.**

Any vacancy in the membership of the MNC shall automatically be filled in by the successor duly elected or appointed by the respective organization to which he or she belongs, if applicable, and who shall serve only for the unexpired term. The concerned organization must submit the name of the successor to the Office of the Mayor, and the Sangguniang Bayan for their information and guidance. The name of the successor will be ipso facto included in Section 1 of this Order.

**SECTION 5. REPEALING CAUSE.**

All other orders, rules, regulations and issuances or parts thereof which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

**SECTION 6. EFFECTIVITY CLAUSE.**

This Executive Order shall take effect immediately.
