EXECUTIVE ORDER NO. 23
Series of 2021

AN ORDER STRICTLY IMPLEMENTING THE GUIDELINES AND HEALTH PROTOCOLS FOR TOURIST, TOUR OPERATORS, TOUR GUIDES, HOTEL ACCOMMODATIONS AND TOURIST BOAT OPERATORS WITHIN THE MUNICIPALITY OF ANDA, PANGASINAN

WHEREAS, Republic Act No. 9593, an act declaring a national policy for tourism as an engine of investment, employment, growth and national development and strengthening the Department of Tourism and its attached agencies to effectively and efficiently implement that policy and appropriating funds thereof;

WHEREAS, in Joint Memorandum Circular NO. 2014-001, the Department of Tourism (DOT) and the Department of Interior and Local Government (DILG) issued guidelines in accordance with Republic Act 9593, to ensure that LGU's are able to pursue their Local Economic Development (LED) program through tourism that will lead to greater private sector investment and job opportunities for more local communities;

WHEREAS, Municipality of Anda consists of 12 islands, five sandbars and beaches with a wide range of qualities. Although many beaches have white sand, most are narrow which limits the amount of activity and their appeal except TONDOL WHITE SAND BEACH. The islands, on the hand, offer some of the best settings for resort, weather sports and adventure tours. The mangrove forest that thrive around the island town obviously are major tourist destinations for wildlife interactions. Some trails present good beach forest in Barangay Tondol, Imbo, Cabungan, Poblacion, Dolaoan and Macaleeng;

WHEREAS, in the deliberation of the Municipal Tourism Council (MTC) on March 09, 2021, the following measures were adopted;

NOW, THEREFORE, I, JOGANIE C. RARANG, by virtue of the powers vested in me by law as the Municipal Mayor do hereby order strictly implementing the guidelines and health protocols for tourist, tour operators, tour guides, hotel accommodations and tourist boat operators as follows:

SECTION 1. TOURIST TRAVEL REQUIREMENTS:

- a. Travel arrangement with DOT accredited tour operator, travel agents, confirmed pre-arranged accommodation;
- b. Tourist at the border must have approved and confirmed booking and health declaration with valid I.D;

SECTION 2. TOURIST UPON ARRIVAL.

- a. Sign on the logbook at the Tourism Information Area.
- b. Confirmation booking must be presented. Tourist must be guided by the Tourism Personnel in the absence of pre-arranged booking;
- c. Secure Environmental Fee official receipt;
- d. Subjected for regular temperature check.

SECTION 3. TOURISM INFORMATION AREA.

- a. All Tourism Service Provider must be DOT accredited establishment and secure necessary permits to the Municipal Government of Anda;
- b. All pre-arranged booking by the Tour Operators shall be coordinated through the PNP at checkpoint in Anda Bridge;
- c. Tourist/Guest shall be advised that the environmental fee shall be in the amount of Thirty-Five (₱35.00) Pesos only;
- d. Shall provide briefing and necessary information for tourist before they proceed to their destination;
- e. Ensure that accommodation establishment shall abide by IATF Safety and Health Protocol.

SECTION 4. HOTEL ACCOMMODATIONS.

- a. Provide separate Log Book for Local Tourist (Andanians), tourist outside Anda and including visitors;
- b. All guest/tourist must be assisted and supervised within the destination of their stay in the resort;
- c. Maintain cleanliness, proper hygiene and proper disposal of waste materials;
- d. Over-charging of fees and charges is strictly prohibited.
- e. Tourist must submit or send thru e-mail all pre-arranged booking to Municipal Tourism Office (andapangasinantourism@gmail.com).

SECTION 5. TOURIST ASSISTANCE DESK.

- a. Provide necessary information and assistance to tourist during their stay;
- b. Coordinate with the CVO's and detailed PNP Personnel for safety and security of tourist.

SECTION 6. BOAT OPERATORS.

- a. Boat operators to provide with lifebuoy ring, life jacket and life-saving equipment;
- b. Identify safe docking place where tourist can view the scenery of the beach;
- c. Comply with the health and safety protocols imposed by the IATF and the Local IATF during this pandemic;
- d. Compliance with the Mun. Ordinance No. 2, S2004 on the management of solid waste.
- e. Compliance with the Municipal Ordinance No. 04, S2012, imposing fees and charges in TWSB area located at Brgy. Tondol, Anda, Pangasinan
