**REORGANIZING/RECONSTITUTING THE COMPOSITION OF THE TRAFFIC  
MANAGEMENT COUNCIL (TMC) OF THE MUNICIPALITY OF ANDA, PANGASINAN**

**WHEREAS**, Section 444 (b) (2) Of RA 7160 annotated the Municipal Mayor as the Chief Executive of the Municipal Government, shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers provided for under Section 22 of this Code;

**WHEREAS**, Anda is classified as third-class municipality. Economy is progressing as a system of production and consumption embraces the sum total productive activity within the municipality and that part of its hinterlands which is dependent to as mark degree in facilities and services available in the area;

**WHEREAS**, the major road lines and streets in Anda may only designed as 'SINGLE LANE'. Motorized vehicles tremendously increased that creates congestion in the municipal streets and thoroughfares;

**WHEREAS**, in order to ease the congestion and traffic problem in the municipality, it is imperative to impose street implementation of the Comprehensive Traffic Code of Anda, Pangasinan.

**NOW, THEREFORE, I, JOGANIE C. RARANG**, Municipal Mayor of Anda, Pangasinan by virtue of the powers vested in me by law, do hereby order:

**Section 2. Duties and Functions of Traffic Management Council (TMC).**

1. Prepare and propose the Annual Budgetary requirements for the efficient operation of the TMC and for the effective implementation of the ordinance and shall be incorporated under the Office of the Mayor as the implementing office;
2. Conduct public information campaign and program on the provisions of the Traffic Ordinance;
3. Recruit and hire Traffic Enforcers and likewise dismiss the same with legal cause. Creation of Traffic and Parking Management Officer or other body, agency for the implementation of traffic rules and regulation;
4. Update and propose any amendments to the Traffic Code for review and coordination of the Sangguniang Bayan;
5. Provision of the Traffic Citation Ticket;
6. Perform other such powers, functions and duties as may be prescribe by pertinent laws or ordinance.

3.b Duties and Responsibilities

2. To cause for the dissemination of information on the Traffic Rules and Regulations;
3. Perform such other duties and responsibilities prescribe by the Council

**Section 4. Separability Clause.** Should any provision of this Order be declared invalid or unconstitutional, the other provisions unaffected thereby shall remain valid and subsisting.

**Section 5. Repealing Clause.** All orders, proclamations, rules, regulations, or parts thereof, which are inconsistent with any provisions of this Order are hereby repealed or modified accordingly.

**Section 6. Effectivity.** This Order shall take effect immediately in the exigency of public health and service.
