**EXECUTIVE ORDER NO. 26**  
**Series of 2021**

**AN ORDER ADOPTING EXECUTIVE ORDER NO. 0027-A-2021 OF PANGASINAN GOVERNOR AMADO I. ESPINO III ON SUPPLEMENTING EXECUTIVE ORDER NO. 0027-2021 TO ASSIST THE IMPLEMENTATION OF IATF-EID RESOLUTION NO. 104, SERIES OF 2021 IN THE MUNICIPALITY OF ANDA, PANGASINAN**

**WHEREAS**, in the past few days, there has been a continuous spike of COVID-19 cases nationwide especially in the National Capital region (NCR) and its neighboring provinces, as we have registered several record highs in our daily new COVID cases, the most recent of which is the 9,838 new cases on March 26, 2021 which is the current all-time high by far;

**WHEREAS**, the Inter-Agency Task Force of the Management of Emerging Infectious Diseases (IATF-EID) issued Resolution No. 104, Series of 2021, placing under General Community Quarantine the provinces of Bulacan, Cavite, Laguna, and Rizal, together with the highly-urbanized cities of the NCR, and the municipality of Pateros, treating the foregoing as one Area;

**WHEREAS**, the said IATF-EID Resolution No. 104, Series of 2021 restricted travel only with the said Area, and imposed several regulations on the conduct of people therein such as common curfew, limited operations of businesses, prohibited religious gatherings, and others;

**WHEREAS**, the Municipality of Anda issued EO 25, S2021 adopting EO No. 0027-2021 for the Strict Implementation of Health Protocols and Guidelines for the Observance of Lenten Season in the Municipality of Anda;

**WHEREAS**, there is a need to implement complementary restrictions within the Municipality of Anda to support the efforts of the National Government in curbing the increasing number of cases in NCR and the surrounding area;

**NOW, THEREFORE, I, JOGANIE C. RARANG**, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. TRAVEL RESTRICTIONS.** In line with the IATF-EID's directive to prevent non-essential external travel from the provinces of Bulacan, Cavite, Laguna, Rizal, the municipality of Pateros, and the cities of NCR, the following travel restrictions are hereby implemented:

- A. Persons from the abovesaid places shall be denied entry into Anda for as long as the regulations under IATF-EID Resolution No. 104, Series of 2021 remain in force;
- B. Person from Anda shall not be allowed to travel to the abovesaid places during the effectivity of the regulations under IATF\_EID Resolution No. 104, Series of 2021;
- C. For travels to and from areas other than the abovementioned place/s, the guidelines under Executive No. 0018-2021, Provincial Ordinance No. 261-2021, and Executive Order No. 25, S2021 of the Municipality of Anda remain in force.

**SECTION 2. EXCEPTIONS.** Essential travel, including but not limited to travel by frontline services, government personnel, emergency and humanitarian cases, and movement of cargo shall remain unhampered.


**SECTION 3. DOCUMENTARY REQUIREMENTS.** The traveler must present any competent proof of identity, document stating workplace address, or any proof of essential travel in border checkpoints for the purpose of assessing the application of the preceding Sections.

**SECTION 4. ENFORCEMENT.** The local Philippine National Police (PNP) are hereby empowered to enforce the restrictions of this Order in border checkpoints around the Municipality of Anda. Component LGU's are likewise directed to assist the implementation of this Order in their respective border checkpoints.

**SECTION 5. SEPARABILITY CLAUSE.** Should any provision of this Order be declared by a court competent authority as invalid or unconstitutional, the remaining provisions not adversely affected thereby shall remain in full force and effect.

**SECTION 6. EFFECTIVITY CLAUSE.** This Order shall take effect immediately until or unless subsequently amended/revoked/revised. All orders, rules, regulations, promulgations, circulars, and/or issuances by the IATF and/or concerned national government offices/agencies are hereby adopted.
