**EXECUTIVE ORDER NO. 29**

**“REORGANIZING/RECONSTITUTING THE MUNICIPAL ANTI-DRUG ABUSE  
COUNCIL OF THE MUNICIPALITY OF ANDA, PANGASINAN”**

**WHEREAS**, the 1987 Philippines Constitution mandates that the government shall promote the quality of life of the people;

**WHEREAS**, Section 16 of the Local Government Code provides that Local Government Units shall pursue undertakings to improve public morals and maintain peace and order, among other equally significant concerns;

**WHEREAS**, the increasing use of illegal drugs has significantly contributed to the incidence of heinous crimes.

**WHEREAS**, the problem on illegal drugs has to be addressed much more effectively to help ensure community peace and harmony;

**WHEREAS**, DILG Memorandum Circular No. 98-227 dated 2 December 1998, as amended, enjoins local government units to create their Local Anti-Drug Abuse Councils;

**NOW THEREFORE, I, JOGANIE C. RARANG**, Municipal Mayor of Anda, Pangasinan by virtue of the powers vested in me by law, do hereby reorganize/reconstitute the Municipal Anti-Drug Abuse Council of the Municipality of Anda, Pangasinan as follows:

**SECTION 2. ROLES AND RESPONSIBILITIES**

- B. Provide for an effective mechanism for the coordination of existing services and programs and those which might be developed in the immediate future.
- C. Provide for a mechanism to obtain funds, volunteers, facilities and technical expertise; and
- D. Perform other related responsibilities as may be assigned by competent authorities'
