**AN ORDER IMPLEMENTING DILG MEMORANDUM CIRCULAR NO. 2021-050 ON
MINIMUM PUBLIC HEALTH STANDARDS ESPECIALLY ON THE ALLOWABLE
PUBLIC OR MASS GATHERING IN THE MUNICIPALITY OF
ANDA, PANGASINAN**

WHEREAS, President Rodrigo Duterte in his April 28, 2021 “Talk to the People on Coronavirus Disease 2019” directed all LCEs to implement and to observe the basic health protocols and measures as contained in various IATF Resolutions especially the prohibition on the holding of mass gatherings, and that failure of the same will be dealt with accordingly;

WHEREAS, The Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF), has adopted the Omnibus Guidelines in the Implementation of Community Quarantine in the Philippines, wherein various levels of Community Quarantine have been defined and specific guidelines therein have been stated;

WHEREAS, the same IATF Guidelines provide that all Local Government Units shall adopt, coordinate, and implement guidelines which the IATF may issue on the COVID-19 situation, consistent with their respective mandates and relevant laws, rules, and regulations; and the IATF, has updated the aforementioned Omnibus Guidelines last April 15, 2021, providing for the subject prohibitions/limitations on public and mass gatherings.

NOW, THEREFORE, I, JOGANIE C. RARANG, by virtue of the powers vested in me by law as Municipal Mayor of Anda, Pangasinan, do hereby allow public and mass gathering under the Modified General Community Quarantine (MGCQ) provided under Memorandum Circular No. 2021-050 as follows:

SECTION 1. ALLOWABLE TYPE OF GATHERING UNDER MGCQ.

- 1.1. Gatherings outside residence up to 50% of seating or venue capacity;
- 1.2. Gatherings at residences up to 50% of seating or venue capacity;
- 1.3. Gatherings for the provision of government services and authorized humanitarian activities is allowed;
- 1.4. Religious gatherings up to 50% of seating or venue capacity, limited to religious worship or service and subject to LGU regulations;
- 1.5. Gatherings for necrological services, wakes, inurnment funerals for those who died of causes other than COVID-19 up to 50% of seating or venue capacity;
- 1.6. Mass gatherings such as movie screenings, concerts, sporting events, entertainment activities, work conference up to 50% of seating or venue capacity; venue shall be compliant with ventilation standards set by DOLE;
- 1.7. LGU – initiated gatherings up to 50% of seating or venue capacity; venue shall be compliant with ventilation standards set by DOLE;





SECTION 2. SEPARABILITY CLAUSE. Should any provision of the Order be declared invalid or unconstitutional, the other provisions unaffected thereby shall remain valid and subsisting.

SECTION 3. REPEALING CLAUSE. All orders, proclamations, rules, regulations, or parts thereof, which are inconsistent with any provision of the Order are hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY. This Order shall take effect immediately and shall remain effective during the period of Modified General Community Quarantine (MGCQ) until revoked or amended.
