**AN ORDER PROVIDING SUPPORT TO THE EXISTING PANTAWID PAMILYA
AND GRADUATING HOUSEHOLD BENEFICIARIES IN THE
MUNICIPALITY OF ANDA, PANGASINAN**

WHEREAS, Section 17 of the Republic Act No. 761, commonly known as the Local Government Code, enumerated the Basic Services and Facilities to be provided by the Local Government Units (LGUs) to include social services that consist of programs and projects on child, youth, women, elderly, disabled persons, family and community welfare as well as other pro-poor projects;

WHEREAS, Section 9 of the Republic Act No. 11291, entitled Magna Carta of the Poor, stipulated the engagement of LGUs in the formulation and implementation of National Poverty Reduction Plan;

WHEREAS, Republic Act No. 11310, known as Pantawid Pamilyang Pilipino Program (4Ps) Act, has been approved and signed into law on 17 April 2019. Subsequently, its implementing Rules and Regulations (IRR) was issued in December 2019;

WHEREAS, Section 4 of the 4Ps Act IRR states that the provision of conditional cash grants to household beneficiaries shall only be for a period of maximum of seven (7) years to improved the health, education and nutritional aspects of their life;

WHEREAS, Section 19 of the 4Ps Act IRR stated that the convergence of programs and services of various agencies of the government implementing multi-stakeholder programs and services for the poor that shall guarantee complementation and seamless convergence in ensuring that the 4Ps household beneficiaries are alleviated form poverty and remain non-poor even after the prescribed maximum period for the conditional cash grants;

WHEREAS, Section 32 of the 4Ps Act IRR further enumerates the conditions in 4Ps household beneficiaries must exit from the Program to include the graduation of beneficiaries who have manifested improvement in their level of well-being;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan by virtue of the powers vested in me by law, do hereby order to support the existing Pantawid Pamilya and graduating household beneficiaries.

SECTION 1. LGU SUPPORT TO THE 4P'S AS FOLLOWS:

- 1.1. Shall support the 4Ps household beneficiaries who will exiting to sustain the gains of the programs;
- 1.2. Shall support the 4Ps household beneficiaries who will be graduating from the program to prevent them from sliding back to poverty;
- 1.3. Shall give priority to 4Ps household beneficiaries in all programs and services available at the LGU without prejudice to the existing guidelines;
- 1.4. Through the Pantawid Pamilya Municipal Advisory Council (MAC), spearheaded by the Municipal Social Welfare and Development Officer (MSWDO), shall craft the Sustainability Plan;

- 1.5. Through the Local Chief Executive, shall approve the Sustainability Plan as recommended by the MAC members;
- 1.6. To appropriately execute the approved Sustainability Plan and further recalibrate if needed;
- 1.7. The MAC, on the other hand, shall discuss the progress of the approved Sustainability Plan as a regular agenda item during MAC meetings;
- 1.8. Through the MSWDO, shall submit the Post Intervention Feedback Report six (6) months after the approval of the Sustainability Plan.

SECTION 2. SEPARABILITY CLAUSE. Should any provision of the Order be declared invalid or unconstitutional, the other provisions unaffected thereby shall remain valid and subsisting.

SECTION 3. REPEALING CLAUSE. All orders, proclamations, rules, regulations, or parts thereof, which are inconsistent with any provision of the Order are hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY. These Order shall take effect immediately until amended, modified or revoked.
