**EXECUTIVE ORDER NO. 44**

**REORGANIZING/RECONSTITUTING THE MUNICIPAL SOLID WASTE  
MANAGEMENT BOARD OF THE MUNICIPALITY OF ANDA PANGASINAN**

**WHEREAS**, Section 12 under Article I of Republic Act. No. 9003 provides for the creation of a Municipal Solid Waste Management Board that shall prepare, submit and implement plan for the safe and sanitary management of solid waste generated in areas under as geographic and political coverage;

**WHEREAS**, the increasing volume of garbage is posing a serious threat to the general welfare and health of the people, as well as, to the integrity of the environment;

**WHEREAS**, this health and environment problem, therefore, requires utmost attention and cooperation among the concerned national government agencies, local government unit's business community, civil society, and the people in general;

**NOW, THEREFORE, I, JOGANIE C. RARANG**, *Municipal Mayor of Anda, Pangasinan*, by virtue of the powers vested in me by law, do hereby reorganize/reconstitute the Municipal Solid Waste Management Board of the Municipality of Anda, Pangasinan as follows:

**Section 2. Roles and Responsibilities:**

- A. Develop the Municipal Solid Waste Management Plan that shall ensure the long-term management of solid waste, as well as integrate the various solid waste management plans and strategies of the barangays in its area of jurisdiction. In the development of the Solid Waste Management Plan, it shall conduct consultations with the various sectors of the community;
- B. Adopt measures to promote and ensure the viability and effective implementation of solid waste management programs in its component barangays;
- C. Monitor the implementation of the Municipal Solid Waste Management Plan through its various political subdivisions and in cooperation with the private sectors and the NGOs;
- D. Adopt specific revenue-generating measures to promote the viability of its Solid Waste Management Plans;

- E. Convene regular meetings for purposes of planning and coordinating the implementation of the solid waste management plans of the respective component barangays;
- F. Oversee the implementation of the Municipal Solid Waste Management Plan;
- G. Review every two (2) years or as the need arises the Municipal Solid Waste Management Plan for purposes of ensuring its sustainability, viability, effectiveness and relevance in relation to local and international developments in the field of solid waste management;
- H. Develop the specific mechanic and guidelines for the implementation of the Municipal Solid Waste Management Plan;
- I. Recommend to appropriate local government authorities' specific measures of proposals for franchise or build-operate-transfer agreements with duly recognized institution, pursuant to R.A. 6957, to provide either exclusive or non-exclusive authority for the collection, transfer, storage, recycling or disposal of municipal solid waste. The proposals shall take into considerations appropriate government rules and regulations on contracts, franchises, and build-operate-transfer agreements;
- J. Provide the necessary logistical and operational support to its component barangays in consonance with subsection (f) of Section 17 of the Local Government Code;
- K. Recommend measures and safeguards against pollution and for the preservation of the natural ecosystem;
- L. Coordinate the efforts of its component barangays in the implementation of the Municipal Solid Waste Management Plan;
- M. Call on any concerned agency or sector, as it may deem necessary, for support or other appropriate action.

**Section 3. Meetings and Quorum:**

- A. The Municipal Solid Waste Management Board shall meet at least once a month or often as may be necessary;
- B. The majority of the members of the Board shall constitute a quorum. The Chairman must be present when budgetary proposals are prepared and the affirmative vote of all majority of its members shall be necessary for the purpose;

**Section 4. Effectivity:** This Executive Order shall take effect immediately.
