EXECUTIVE ORDER NO. 45
Series of 2021

REORGANIZING/RECONSTITUTING THE MUNICIPAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (MCAT-VAWC) OF THE MUNICIPALITY OF ANDA, PANGASINAN

WHEREAS, Republic Act 9710 known as the Magna Carta of Women, is a comprehensive Human Rights of Filipino Women;

WHEREAS, Republic Act No. 9208 declares that the state shall give highest priority to the enactment of measures and development of programs that will promote dignity, protect the people from violence and exploitation, eliminate trafficking in persons, and mitigate pressures for involuntary migration and servitude of persons to ensure their recover, rehabilitation, and reintegration;

WHEREAS, Republic Act No. 9262, on the other hand, underscores the commitment on state on safeguarding the dignity of women and children while guaranteeing full respect of their human rights and to protect them from violence and threats personal safety and security;

WHEREAS, these two laws likewise provide stronger mandates and direction and relevant government agencies and stakeholders to immediately address human trafficking and VAWC by organizing Inter-Agency Councils (IACS) for trafficking (Section 20 of RA 9028) and VAWC (Section 39 of RA 9262);

WHEREAS, these councils are composed of government agencies and selected non-government organization whose mandates are relevant VAWC and anti-trafficking initiatives, respectively;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby organize/reconstitute the Municipal Committee on Anti-Trafficking and Violence Against Women and Children (MCAT-VAWC) of the Municipality of Anda, Pangasinan as follows:

SECTION 2. Rules and Functions.

- a) Institute policies and program to protect women and children who are victims of trafficking (formulate local ordinances and resolution);
- b) Create and establish system on surveillance, investigation, and rescue to ensure effective and efficient coordination;
- c) Undertake information, education, and advocacy campaign against trafficking in persons and VAWC;
- d) Monitor and oversee the strict implementation of RA 9208, RA 9262, and other related laws for the Protection of Women and Children, and for the Inter-Agency Committee on AT and VAWC of action;
- e) Monitor and coordinate with the BARANGAY VAW DESK PERSON in their duties and functions such as but not limited to:
 1. Respond to gender-based violence cases brought to the barangay.
 2. Record number of gender-based violence handled by the barangay and submit a quarterly report on all cases of VAWC to the DILG and DSWD.
 3. Keep VAW case records confidential and secured, and ensure that only authorized personnel can access it.
 4. Assist victims of VAW in securing barangay protection order (BPO) and access necessary services.
 5. Develop the barangay-gender responsive plan in addressing gender-based violence, including support services, capacity building and referral system.
 6. Coordinate and refer cases to government agencies, non-government organizations, institutions and other service providers as necessary.
 7. Address other forms of abuse committed against women especially senior citizens, women with disabilities and other marginalized groups.
 8. Lead advocacies on the elimination of VAW in the community and performed other related functions.

SECTION 3. Effectivity.

This Executive Order shall take effect immediately.
