**EXECUTIVE ORDER NO. 40**  
**Series of 2020**

**AN ORDER PROVIDING SAFETY GUIDELINES AND PRECAUTIONARY MEASURES  
TO BE FOLLOWED STRICTLY WITH CERTAIN RESTRICTIONS IN TIME OF CRISIS  
BROUGHT ABOUT BY COVID-19 VIRUS**

**WHEREAS**, Art. 84 (VII), the Municipal Mayor, as the Chief Executive of the Municipal Government, shall exercise such powers and carry out such emergency measures as maybe necessary during and in the aftermath of man-made and natural disasters and calamities;

**WHEREAS**, the following personal preventive measures shall be strictly followed, such as:

1. All individuals who travelled to Anda from areas with confirmed COVID-19 cases, including Metro Manila shall hereby observe a 14-day mandatory quarantine period. This policy does not apply to drivers and staff of public conveyances and those whose job require a continuous change in location;
2. Persons who travelled outside Anda shall be recorded for tracing purposes only.
3. Everyone is strongly encouraged to remain home, minimize contact with others, and maintain a distance of 1 meter or roughly 3.3 feet from one another;
4. Travel to, from, and within Anda is highly discouraged;
5. All private gatherings are discouraged;
6. Everyone must practice and advocate cough etiquette by covering the mouth and nose with disposable tissue paper when coughing and dispose of the tissue paper immediately afterwards. In the absence of tissue paper, one must cover the mouth and nose with elbow pit;
7. All must carry our proper hand washing with soap and water. If not available, use disinfectants such as rubbing alcohol or hand sanitizer. Avoid touching any part of the face;
8. The following people should wear face mask:
  - a. PUM (those who have possibly been exposed to COVID-19 carries but without symptoms)
  - b. PUI (those who show COVID-19 symptoms)
  - c. Individuals who are sick
  - d. Those in direct contact of PUM, PUI, or persons with COVID-19
  - e. And all drivers and conductors of all public conveyances
9. Those using masks are directed to avoid touching the face or mask and only do so after sanitizing one's hands;
10. As per DOH, persons who believe they are PUM are advised to self-quarantine at home. PUI shall consult their respective City/Municipal Health Officer before taking further action;
11. Spitting in public areas is strictly prohibited.

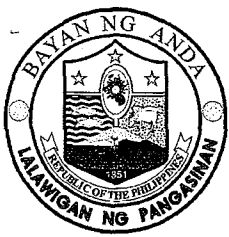
**WHEREAS**, the following Public Preventive Measures shall be strictly followed, such as:

1. Pursuant to EO. 37 S2020, classes in all levels of both public and private schools in the municipality shall be suspended from March 16, 2020 to April 12, 2020
2. All public gatherings are hereby ordered postponed or cancelled, including but not limited to masses, forms of worship, fiestas, general assemblies, seminars, public hearings, rallies, fests and similar events;
3. Financial institutions, utilities, loan institutions and similar establishments are likewise requested to exercise leniency in imposing surcharges and penalties on due or overdue bills;
4. Consumptions of alcoholic beverages is banned in public. All consumption must transpire in private residences;
5. All establishments must have disinfectants readily available for public use;
6. Install checkpoint at ANDA Bridge, 24 hours. Check the visitor's body temperature. If the body temperature reached 38° or higher, the person will be interviewed and check for any symptoms of COVID-19;
7. Barangays are also directed to established checkpoint of their respective area of jurisdiction.
8. BHERTS are likewise required to submit daily monitoring report to RHU;
9. Curfew hours shall be strictly implemented from 8:00 PM to 5:00 AM;
10. Temporary closure of Tondol White Sand Beach (TWSB) and other tourist spots of this municipality is strictly implemented, as per EO 38 S2020;
11. The buying public is encouraged to patronized locally produced meat products in order to avoid consumption of contaminated meat such as ASF.

**WHEREAS**, Identification of Quarantine Areas. Public and private hospitals shall identify, prepare, and equip quarantine areas within their respective premises. All Barangays shall designate their respective Barangay Health Centers as Barangay Special Care Facility.

**WHEREAS**, Prohibition on Hoarding and Reselling. Hoarding and/or reselling of basic commodities with price spikes is strictly prohibited. All sellers must observe the Department of Trade and Industry (DTI) price freeze on essential medicines, basic medical supplies, such as face masks, rubbing alcohol, hand sanitizers, and basic food supplies, such as but not limited to canned sardines, bread, instant noodles, coffee and bottle water. The Price Monitoring Board of the LGU will conduct regular monitoring and inspection.

**WHEREAS**, Prohibition on the Spread of Fake News. Spreading unverified reports regarding COVID-19, whether which malice or not is strictly prohibited, intentionally providing misinformation is a violation of Sec. 9 (b) of RA 11323 and shall be penalized accordingly.
