EXECUTIVE ORDER NO. 121

**AN ORDER PROVIDING ADDITIONAL MEASURES IMPOSED BY
ANDA ANTI COVID-19 TASK FORCE IN THE OPERATION OF PUBLIC MARKET,
PRIVATE ESTABLISHMENT, GROCERIES AND STORES IN THE
MUNICIPALITY OF ANDA, PANGASINAN**

WHEREAS, in Section 17 of the Local Government Code, RA 7160, Local Government Units shall exercise such other power and discharge such other functions and responsibilities as all necessary, appropriate or incidental to efficient and effective provision of the basic services and facilities;

WHEREAS, in view of the recent amendments to the Omnibus Guidelines on the Management of Community Quarantine in the Philippines and the issuances of competent government agencies, there is a need to provide additional measures imposed by Anda Anti COVID-19 Task Force;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby implement the following additional measures imposed by the Anda Anti COVID-19 Task Force;

SECTION 1. PUBLIC MARKET, PRIVATE ESTABLISHMENT, EATERIES, GROCERIES, AND STORES.

- a. **OPEN** from Monday to Sunday
- b. Time: 6:00 AM to 5:00 PM
- c. Non-Residents (Dayu):
Allowed to operate – Monday and Friday only

SECTION 2: HEALTH PROTOCOL.

- a. Practice social distancing at least one (1) meter apart
- b. Wearing of facemask and face shield always
- c. Operators shall provide sanitizers and disinfectant
- d. Plastic barriers between your merchandise and buyer

SECTION 3. NON-RESIDENTS.

- a. Non-Residents are allowed to enter in the Public Market, provided that they have Medical Certificate.
- b. Non-Residents with Medical Certificate that exceed three (3) days from the date of issuance shall undergo quarantine.

SECTION 4. SEPARABILITY CLAUSE. Should any provision of the Order be declared invalid or unconstitutional, the other provisions unaffected thereby shall remain valid and subsisting.

SECTION 5. REPEALING CLAUSE. All orders, proclamations, rules, regulations, or parts thereof, which are inconsistent with any provision of this Order are hereby repealed or modified accordingly.

SECTION 6. EFFECTIVITY. This Order shall take effect immediately and shall remain effective until revoked or amended.
