**AN ORDER PRESCRIBING GUIDELINES ON THE REOPENING OF
TONDOL WHITE SAND BEACH (TWSB) AND THE OPERATIONS OF HOTELS
AND OTHER ACCOMMODATION ESTABLISHMENTS INCLUDING OTHER
TOURIST SPOTS UNDER A COMMUNITY QUARANTINE IN THE
MUNICIPALITY OF ANDA, PANGASINAN**

WHEREAS, on May 2020, the Department of Tourism (DOT) issued Administrative Order (AO) No. 2020-002 or the Guidelines on the Operation of Hotels and Other Accommodation Establishments Under a Community Quarantine;

WHEREAS, on June 2020, the DOT issued AO No. 2020-002-A amending AO No. 2020-002 to provide guidelines on the grant of Provisional Certificates of Authority to Operate to Accommodation Establishments while other requirements are pending submission;

WHEREAS, there is a need to further ensure that in the reopening of Tondol White Sand Beach (TWSB) and other beaches including Accommodation Establishments comply with Minimum Public Health Standards, and that their operations are in accordance with updated guidelines by Anda Anti-COVID Task Force and other sector-relevant regulations.

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby order prescribing guidelines on the reopening of Tondol White Sand Beach (TWSB) and the operations of hotels and other accommodation establishments including other tourist spots under a Community Quarantine in the Municipality Of Anda, Pangasinan.

SECTION 1. FOR STAKEHOLDERS (RESORT OWNERS AND CARETAKERS).

- Mandatory wearing of face mask/face shield and observance of social distancing all the time within the resort premises;
- Use of thermal scanners at incoming guests at the entrance of the resort;
- Alcohol must be available all the time and be placed at strategic places within the resort;
- Minimize close contact between the resort staff and guests;
- 50% of resort capacity is allowed. Submit daily record of tourist to Tourism Office;
- Separate areas for eating and drinking activities for each group of guests with strict observance of social distancing;
- To issue document as proof of advance booking to the guests to be presented at the Anda checkpoint;
- Provide the necessary protection of resort like face mask/face shields, alcohol, surgical gloves for cleaning, disinfectants, etc;

- Face masks should always be available in the resort and Tourism Office at very reasonable price;
- Provide ice box for the guests;
- Post contact nos. within the resort premises of vital government agencies involved with the prevention of COVID-19 like local IATF, police, local health office, etc;
- For resorts with swimming pools, use of the pool is allowed only when the guests are coming from only one group;
- Approved protocols should be posted or published at the resort's website, FB page and other sites to make sure that the prospective guests will have advance knowledge of these guidelines before coming to Tondol;
- Report in case of symptoms with fever, colds and diarrhea to the Tourism Office.

SECTION 2. FOR THE LGU.

- Determine the actual capacities of the resorts;
- Only guests with advance bookings on-line are allowed entry. No walk-ins;
- Open Anda Public Market to non-residents for three (3) days provided they have Medical Certificate;
- Require tourists to secure Municipal Health Clearances that they are not in contact with COVID-19 patient;
- Require tourists at the checkpoint in the proof of advance booking issued by the resort owner, Municipal Health clearance issued by the local health units in their area of residence, Xerox copy of individual government issued ID for each tourist, other docs as maybe determined by the local IATF;
- Strict observances of social distancing at the beach area;
- Resorts caught violating approved protocols maybe ordered suspended or temporarily closed upon the discretion of the local IATF;
- Monitoring teams must be set-up at the Tondol Public Information Office for random checking;
- Conduct a briefing on proper disinfection of rooms and facilities, proper disposal of wastes and proper dealings with the tourists/guests, etc;
- Question: what is the protocol if one or more tourists from a group are found feverish (37.8 C) at the checkpoint or at the resort entrance? I strongly suggest that the whole group must be denied entry as all of them could have already been infected by the suspected guest/s. Rebook at another date but should be 14 days after date of denied entry.
- Tourists with cough, fever, and diarrhea are advised to go home;
- Tourists coming from places/cities positive with COVID-19 are not allowed to enter Anda.

SECTION 3. FOR LOCAL TOURISTS/GUESTS

- Provide master lists of guests joining the group including the driver if vehicle is rented, containing the following (attach health certificate and photocopies of individual ID)s:
 - a. Complete name
 - b. Full address
 - c. Active contact number
 - d. Age
 - e. Place of origin
 - f. Birth date

- Secure Municipal/Brgy. Health clearances of all guests including the driver if the vehicle is rented;
- Bring your own eating utensils. Use of disposable utensils is also encourage;
- Avoid or minimize cash payment. Online full payment is highly recommended;
- Baon or food and drinks should be bought already from place/s of origin;

SECTION 4. TOURISM OFFICE/COUNCIL.

- Create a team to check tourists with legitimate papers;
- Shall provide registration site for tourists;
- Sanitation facilities shall be designated;
- Flow chart for Tourists Guidelines shall be posted in Anda Bridge and Tourism Office
- Check Clearance and provide ID Control Number to day tour visiting Tondol White Sand Beach (TWSB)

SECTION 5. ADVISORY/REMINDER.

- Upon approval of EO No. 114 S2020, Tondol White Sand Beach will be open to the public from 6:00 AM to 6:00 PM.
- Only tourists with booking in the resort are allowed to enter. "NO WALK-IN";
- Curfew hour must be observed from 8:00 PM to 5:00 AM;
- Formulation of on-line questionnaire shall be formulated for tourist;
- Tourist are advised to come early for security reason;
- Below 15 years old and 65 years old above are not allowed to go out and are not allowed in the beach;
- Observe social distancing at least 1 meter apart and observe health protocol;
- Drinking beverages is allowed on private accommodation, however must observe social distancing and health protocol.
- Requirements for tourists from Anda:
 - to be registered
 - to be provided with stub and control no.
- Requirements for tourists outside Anda:
 - Health Certificate
 - Travel Authority
 - Booking Confirmation
 - Registration Anda Checkpoint
 - Stub with Control Number

SECTION 6. SEPARABILITY CLAUSE. Should any provision of the Order be declared invalid or unconstitutional, the other provisions unaffected thereby shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All orders, proclamations, rules, regulations, or parts thereof, which are inconsistent with any provision of the Order are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY. This Order shall take effect immediately and shall remain effective until revoked or amended.
