### *Construction of Box Culvert/Bridge (Torino) with Riprapping and Concreting Road*

1. The *LGU ANDA, PANGASINAN*, through the *LGU DEVT. FUND 2022* intends to apply the sum of *FOUR MILLION TWO HUNDRED EIGHTY THOUSAND NINE HUNDRED SIXTY-THREE PESOS AND EIGHTY CENTAVOS (P4,280,963.80)* being the Approved Budget for the Contract (ABC) to payments under the contract for *CONSTRUCTION OF BOX CULVERT/BRIDGE (TORINO) WITH RIPRAPPING AND CONCRETING ROAD*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *LGU ANDA, PANGASINAN* and inspect the Bidding Documents at the address given below from *8:00AM TO 5:00PM*.

A complete set of Bidding Documents may be acquired by interested bidders on *FEBRUARY 14, 2022 TO MARCH 2, 2022* from given address and website/s below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Five Thousand Pesos (P5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees be presented in person.
6. The *LGU ANDA, PANGASINAN* will hold a Pre-Bid Conference on *FEBRUARY 17, 2022 @ 1:00PM* at *Conference Hall, 2<sup>nd</sup> Floor, Municipal Building Anda, Pangasinan*. which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before *MARCH 2, 2022 not later than 1:00PM at the office of BAC Secretariat*. Late bids shall not be accepted.
