


The LGU ANDA, PANGASINAN, through the 20% DEVELOPMENT FUND 2022 (SOLID WASTE) intends to apply the sum of SEVEN HUNDRED FOURTEEN THOUSAND PESOS (P714,000.00) being the ABC to payments under the contract for GARBAGE DISPOSAL FEE (TIPPING FEE). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The LGU ANDA, PANGASINAN now invites bids for the above Procurement Project. Delivery of the Goods is required by **until the 840 Tons is Consumed**. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
