PROCUREMENT OF GARBAGE DISPOSAL WASTE (TIPPING FEE)**

1. The **LGU ANDA, PANGASINAN**, through the **20% Devt. Fund-Waste Management Program 2024** intends to apply the sum of **Seven Hundred Sixty-Five Thousand Pesos (P765,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **PROCUREMENT OF GARBAGE DISPOSAL WASTE (TIPPING FEE)**.
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The **LGU ANDA, PANGASINAN** now invites bids for the above Procurement Project. Completion of the Works is required **Until the 840 Tons is Consumed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
5. Interested bidders may obtain further information from **LGU ANDA, PANGASINAN** and inspect the Bidding Documents at the address given below during workdays from **8:00AM TO 5:00 PM at the BAC Secretariat**.
6. A complete set of Bidding Documents may be acquired by interested bidders on **January 19, 2024 to February 8, 2024** from given address and website/s below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Pesos (P1,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented in person.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **February 8, 2024 not later than 12:00 noon at the office of BAC Secretariat**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
9. Bid opening shall be on **February 8, 2024 @ 1:00PM** at the Conference Room, 2nd Floor Presidencia de Anda, Anda Pangasinan.

The **LGU ANDA, PANGASINAN** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
