2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The **LGU ANDA, PANGASINAN** now invites bids for the above Procurement Project. Completion of the Works is required **QUARTERLY**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
5. Interested bidders may obtain further information from **LGU ANDA, PANGASINAN** and inspect the Bidding Documents at the address given below during workdays from **8:00AM TO 5:00PM at the BAC Secretariat**.

A complete set of Bidding Documents may be acquired by interested bidders on **January 22, 2024 to February 12, 2024** from given address and website/s below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees be presented in person.
7. The **LGU ANDA, PANGASINAN** will hold a Pre-Bid Conference on **January 26, 2024 @ 1:00PM at Conference Room, 2nd Floor, Presidencia de Anda, Pangasinan** which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **February 12, 2024 not later than 12:00 noon at the office of BAC Secretariat**. Late bids shall not be accepted.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 15**.
9. Bid opening shall be on **February 12, 2024 @ 1:00PM** at the Conference Room, 2nd Floor **Presidencia de Anda, Pangasinan**.
