Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
6. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **JULY 13, 2022 not later 1:00 PM**. Late bids shall not be accepted.
7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
8. Bid opening shall be on **JULY 13, 2022 @ 2:30PM** at the Conference Room, 2nd Floor Municipal Building Anda, Pangasinan.
