A complete set of Bidding Documents may be acquired by interested bidders on **AUGUST 30, 2022 TO SEPTEMBER 19, 2022** from given address and website/s below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Pesos (₱1,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees be presented in person.
6. The *LGU ANDA, PANGASINAN* will hold a Pre-Bid Conference on **September 6, 2022 @ 1:00PM** at *Conference Room, 2<sup>nd</sup> Floor, Municipal Building Anda, Pangasinan*. which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **September 19, 2022 not later than 1:00PM at the office of BAC Secretariat**. Late bids shall not be accepted.
