Procurement of Two (2) Units of Municipal Ambulance

The LGU ANDA, PANGASINAN, through the *TRUST FUND* intends to apply the sum of *FIVE MILLION PESOS (P5,000,000.00)* being the ABC to payments under the contract for *PROCUREMENT OF TWO (2) UNITS OF MUNICIPAL AMBULANCE*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The LGU ANDA, PANGASINAN now invites bids for the above Procurement Project. Delivery of the Goods is required by **60 Calendar days**. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Prospective Bidders may obtain further information from LGU ANDA, PANGASINAN and inspect the Bidding Documents at the address given below during workdays from **8:00AM TO 5:00PM at the Office of BAC Secretariat**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **JULY 15, 2022 TO AUGUST 3, 2022** from the given address and website(s) below: *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIVE THOUSAND PESOS (P5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
6. The LGU ANDA, PANGASINAN will hold a Pre-Bid Conference on **July 22, 2022 @ 4:00pm** at the Conference Room Hall, 2nd Floor, Municipal Building Anda, Pangasinan, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **AUGUST 3, 2022 not later 1:00 PM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on **AUGUST 3, 2022 @ 4:00PM** at the Conference Room, 2nd Floor Municipal Building Anda, Pangasinan.

The LGU ANDA, PANGASINAN *THRU HOPE* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
